The quotation should be sent through either through **Speed Post** and reached at the said office or should be deposited at the **Tender Box** in the Ground Floor beside **Room No. 6** of the institution up to 1:30 P.M. of 24-01-2018 (Wednesday), and the same will be opened at 02:00 P.M. on 24-01-2018 (Wednesday).
3. Incomplete Quotations / quotations with insufficient information if received will be summarily rejected. On any aspect regarding the purchase, the decision of Purchase Committee of Rabindra Mahavidyalaya, Champadanga, Hooghly is final.
4. Interested bidders are requested to visit the official website www.rabindramahavidyalaya.org and for reference information, if any. The sealed quotation should be accompanied at least with the documents of Registration of the firms, shop or dealership or license documents etc.; CST / VAT / GST registrations; other registration certificates from statutory agencies; a copy of this Tender Notice, qualified quotation mentioning the features those are met out of the Tender notice; and Account details for electronic payment or banking transfers (optional);
